## QUALIFICATIONS

- Applications must be postmarked between September 21, 2009 through May 31, 2010, to be considered for rebates. Submitting an application form does not guarantee you will receive a rebate.
- **Rebates will be issued on a first-come, first-served basis until funding is exhausted. Purchases made prior to September 21, 2009 are ineligible.**
- Application form and all required documentation including proof of purchase must be postmarked no later than 45 days from purchase date of qualifying device(s).
- Rebates are only available for high-efficiency device(s) on the Qualifying List at [www.bewaterwise.com](http://www.bewaterwise.com). **Not all device(s) qualify for rebates.**
- Only original sales receipts (purchase date, brand, model number) will be accepted as proof of purchase. **Copies of sales receipts, work orders or job quotes, will not be accepted.**
